

Commercial production of Big Slab Glazed Vitrified Tiles

To tap the vast potential in the GVT space, Exxaro Tiles Ltd has setup a manufacturing facility at its existing plant at Talod, value added large format GVT tiles in admeasuring 9mm/20mm with thickness in various sizes of 800*2400, 800*3000, 800*3200, 1200*1800 & 1200*2400. Installed capacity of the plant is after this is around 11.00 million sq. mtrs per annum which was earlier around 9.6 MSMS.

Total cost for setting up this big slab production line is around Rs. 30 crores at our existing Talod Plant out of Company internal funding. This expansion is expected to generate additional revenue of around Rs. 250 crores at optimum capacity and the same has been staring to commence commercial production by 18th October 2022.

The Company has purchased a "SACMI CONTINUA" Technology based Press, admeasuring 1600mm x 3200mm imported from ITALY to manufacture large glazed vitrified tiles/slabs. The new installation will apply the best latest available technology and manufacturing process in terms of industrial performance, safety and respect for the environment. Expanded product categories would enable the Company to further strengthen brand "EXXARO".

The investment is fully in line with our strategic plan to improve operating efficiencies and growth plan through technology enhancements alongside state-of-the-art manufacturing infrastructure. The new installation will manufacture large size glazed vitrified tiles/slabs admeasuring 9mm/20mm with thickness in various sizes of 800*2400, 800*3000, 800*3200, 1200*1800 & 1200*2400.
